Pls.note"ST.BON/INC/EX-GRA" in pay slip stands for "Statutory Bonus/Incentive/Ex-Gratia".

Pls.link your PAN with Aadhaar.Linking of PAN with Aadhaar is mandatory.

For FY 2021-22, Landlord PAN is mandatory if monthly rent exceed Rs.8333/-.

Effective Sept-2017, Aadhaar No. is mandatory for PF enrollment.Pls. update Form 11 details and submit scan copy of Aadhaar on HGS portal,if not submitted earlier.
