## Dear Sir,

- 1. I, Mohan Ram Goenka, a Company Secretary in Practice (FCS No. 4515, CP No. 2551), Partner of MR & Associates, was duly appointed as a Scrutinizer by the Board of Directors of Peerless Financial Services Limited (herein after referred to as "the Company") for the purpose of Scrutinizing the remote e-voting process under the provisions of Sections 108 & 110 of the Companies Act, 2013 (herein after referred to as "the Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014, Secretarial Standard on General Meetings ("SS-2") issued by the Institute of Company Secretaries of India and other applicable laws, and rules made thereunder as amended (including any statutory modification(s) or re enactment(s) thereof for the time being in force.
- 2. The Management of the Company is responsible to ensure the Compliance with the requirements of the Act and Rules relating to voting on the resolution proposed in the Notice of the Postal Ballot dated 11<sup>th</sup> December, 2023. My responsibility as a Scrutinizer is to ensure that the voting process is conducted in a fair and transparent manner and is restricted to making a Scrutinizer's Report for the votes cast in "favour" or "against" on the resolution proposed in the Notice of the Postal Ballot, based on the report provided by National Securities Depository Limited (NSDL), the agency engaged by the Company to provide remote e-voting facility for voting through electronic means of the Company.
- 3. In terms of the aforesaid Postal Ballot Notice and as per the provisions of Section 108 of the Act read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended, the remote e-voting facility was kept open from Tuesday, 9<sup>th</sup> January, 2024 10.00 A.M (IST) till Friday, 12<sup>th</sup> January, 2024 at 5.00 P.M. (IST) and Members were requested to cast their votes through remote e-voting on the e-voting platform provided by NSDL, conveying their assent or dissent in respect of the resolution.

- 4. The Members holding equity shares as on the "cut-off date" i.e. Saturday, 6<sup>th</sup> January, 2024, were entitled to vote on the resolution proposed in the Notice of Postal Ballot dated 11<sup>th</sup> December, 2023, by remote e-voting.
- At the end of the remote e-voting period on Friday, 12<sup>th</sup> January, 2024 at 5.00 P.M. (IST) the voting portal of NSDL was blocked forthwith.
- The votes were unblocked in the presence of 2 (two) witnesses, neither of whom are in the
  employment of the Company, and e-voting summary statement was downloaded from the e-voting
  website of NSDL (<a href="https://www.evoting.nsdl.com">https://www.evoting.nsdl.com</a>).
- 7. My report on the results of the voting is based on the data downloaded from NSDL in respect of the resolution contained in the Extra Ordinary General Meeting dated 13<sup>th</sup> January, 2024.
- 8. Based on data downloaded from NSDL, 28 members have cast their votes through remote e-voting platform. The brief analysis of the results of the voting through remote e-voting and physical ballot forms, are as under:
